Investigator Doss and Officer Dowell then monitored and witnessed the confidential purchase a six pack of Bud Light Beer from Karla Medina , a clerk at Midway IV at 415 Highway 51 South. Investigator Doss later issued a misdemeanor citation to Medina for Selling Alcohol to Minors (57-5-301).

History:

Midway Market IV was granted a Beer Permit for Off Premise Consumption from the Covington Beer Board on the 27th day of October 2015.

This is the second violation for this establishment.

Midway Market IV was fined \$1000.00 in lieu of suspension on the 14th of August 2018 by the Covington Beer Board for selling beer to a minor on the 13th of April 2018.

Notice of Hearing was sent to Midway Market IV by Certified Mail 13th June 2019; signed June 15th by Midway Market IV; green card signed but not dated and proof of receipt received by Municipal Attorney, Rachel Witherington on June 17

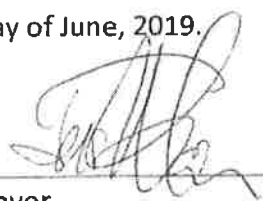

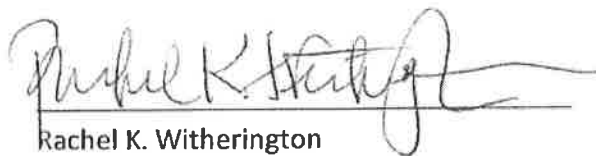
